Pastor's Report!

Wow! We've been dealing with so much as a society over this past fiscal year! And yet, despite all the issues related to Covid-19, and politics, and racial injustice, and murder hornets, and so much more, God has been truly faithful.

We began the year last May in quarantine, meeting remotely as I posted video sermons and we had online groups and meetings. Our first Sunday back in the building together was May 31, 2020, and, despite a slight pull back of ministries during the 'holiday surge,' we haven't missed a beat! We've continued to provide access to worship services online, and several continue to take advantage of that option. And although many predicted the opposite for churches during the pandemic, our giving has been very strong, thanks to your faithfulness and generosity!

We are seeing more people visiting our church, both in-person and online...actually, we're having more visitors than before the pandemic! We are excited about reaching more people with the love and grace of Jesus.

Another great accomplishment this year was the sale of the church-owned rental property at 6953 Wooster Pike. The Board worked for several months to transition the renters out and then closed the sale in July of 2020. With those funds we were able to significantly reduce the church's indebtedness and cut our monthly mortgage payment in half, freeing up funds for ministry!

In August it was great to gather for an outdoor worship service and picnic, seeing many folks who hadn't yet been comfortable coming back to services. It was our highest attended service until Easter this past Spring.

In October we hosted our first-ever **Drive-thru Trunk-or-Treat** and had over 400 people participate! It was a great outreach opportunity, and a way to serve the kids and families of our church and community, especially when so many things had been closed. It was a mazing to see our church pitch in a serve!

In November, I met with the Church Board and Pastor Wendell Brown, our District Superintendent, for the **'Church-Pastoral Review'** that happens every **4** years. Many things were discussed regarding the mission and vision of the church. We determined that we seem to be on the right track and we desire to "continue the church-pastoral relationship...' I guess that means you're still stuck with me as we Love People to Life together in the coming days!

Life Groups

- One in-person group was held in the fall, led by Pastor Pete.
- Conducted a survey in January to assess life group participation and assist in future planning of groups.
- Currently wrapping up two in-person groups, held at the church, and led by Rebecca and Pastor Pete ("Taste and See") and David Applegate ("The Church in Babylon").
- Anticipating new groups later this year

Ladies Bible Study

Ladies Bible Study was able to meet in-person in the fall and then again in the spring after an extended Christmas/ Covid break. They will conclude their study of Romans at the end of May, and then resume in September.

Children's Ministries

- Full operation of the Children's Ministry was hampered by Covid restrictions. Sunday School and Hope Squadron was on hold for several months, with children
 worshipping with parents in regular services.
- Zeida Caywood resigned as Children's Ministry Director. She continues to schedule and plan for Hope Squadron, and teach once a month.
- Hosted first "Trunk or Treat" in October 2020 with good community attendance
- Passport to Missions continues one Sunday each month, led by Lori Applegate

Future Planning:

- Planning for VBS July 5-9, to be led by Teresa Morris, with theme of "Treasured: Discovering You're Priceless to God"
- Seeking new Children's Ministry Director to coordinate and plan for children's events
